## 4. Special Resolution of the Members of MEAO regarding MEAO's change of address

Presented by Laurie Menard, Member of the Board.

- The Corporation surrendered its lease on its expiry at 170 The Donway West, Toronto, in the spring of 2014, and since then the Landlords at the Corporation's former address, the Rockport Group ("Rockport") have allowed the Corporation to continue using 170 The Donway West, Suite 307 as the Corporation's head office address;
- The Corporation has not leased new premises and Rockport gave the Corporation an original deadline of March 31<sup>st</sup>, 2021, which was extended to October 31<sup>st</sup> to redirect their mail;
- The Alliance for Healthier Communities (the "Alliance") has agreed to allow the Corporation to use the Alliance's address of 970 Lawrence Avenue West, Suite 500, Toronto as the Corporation's head office address;
- The Corporations Act (Ontario) requires that a change of location to the Corporation's Head Office requires a Special Resolution of the Corporation's Board of Directors and of its members.

#### Discussion:

 MEAO's new address of 970 Lawrence Avenue West, Suite 500, Toronto, will be its address for the foreseeable future. No end date was determined.

**RESOLUTION:** Now therefore be it resolved that the following special resolution be approved:

- 1. The Corporation approves relocating the Corporation's Head Office address to 970 Lawrence Avenue West, Suite 500 Toronto, Ontario M6A 3B6;
- 2. The Corporation approves management filing a Notice of Change, Form 1 with Service Ontario in order to comply with the requirements under the *Corporations Information Act* (Ontario).
