Denise Magi

Denise is President of The Myalgic Encephalomyelitis Association of Ontario (MEAO). Previously, Denise served as Vice-President and Secretary of MEAO.

Denise has been on steering committees including the initial steering committee that developed a business case proposal which seeks to establish a patient-centered model of medical care and system of service delivery for patients with myalgic encephalomyelitis/chronic fatigue syndrome (ME/CFS), fibromyalgia (FM) and environmental sensitivities/multiple chemical sensitivity (ES/MCS) and other environmentally-linked illnesses. She is dedicated to the cause of establishing a patient-centered health care delivery system to help Ontarians afflicted with environmentally-linked illnesses.

Denise is also representing MEAO on the Minister's Task Force for Environmental Health.

In the public sector, she has long and extensive work experience as a legal assistant and also in the library sciences as a library technician in a Federal Government law library.

Denise is a patient with personal knowledge of ME/CFS, FM and ES/MCS, and is a long standing volunteer and health advocate.
