# 1. Call to Order

Denise Magi, President of MEAO extended a welcome to all members and introduced the current board members, MEAO's lawyer Mr. Brian Iler, Mr. Robert Fugere, the parliamentarian and Wafaa Arbaji, MEAO's administrative assistant.

Mr. Robert Fugere will be assisting with rules of order during the voting process and oversee the election process.

Mr. Brian Iler was in attendance to answer any questions or concerns regarding the newly revised By-laws. Mr. Robert Fugere was in attendance to conduct the election of directors.

The meeting was called to order at 1:49 p.m.

# 2. Resolutions:

### a) Confirmation of new by-law

MEAO Secretary, Adrianna Tetley presented the new by-laws with Mr. Iler taking any questions or concerns from members, if needed.

Revising the old by-laws was a collaborative effort by the board and its members. A copy of the member feedback was included in handout package for reference.

Special thanks to MEAO member Eleanor Johnson for her due diligence and feedback with the by-laws.

### Motion:

Be it resolved that the By-law for The Myalgic Encephalomyelitis Association of Ontario (MEAO) approved by the MEAO Board of Directors on March 29<sup>th</sup>, 2018, be approved as presented, and that this By-law replace all prior versions of MEAO By-laws.

### b) MEAO resolution

MEAO's current objects are outdated and need revisions. This will take time and require members input. In 2018-19, MEAO Board intends to refresh the objects, mandate and mission.

Mr. Brian ller reassured that by passing resolution, MEAO will not be putting its charitable status at risk and will be in compliance.

Concerns expressed by members:

- not all members approve of MEAO supporting all three of the medical conditions (ME/CFS, FM, ES/MCS);
- a shift from a member based to an advocacy organization with no member input, resulting in fewer members; and
- the need for more communications via newsletters and other supports.

The members were thanked for their comments. Overall, the members were in support of the resolution. Concerns were more focused on changes to object and mandate. Members were assured that this was the work for 2018-19.

The members were presented with a written list of nominee biographies and the nominees were introduced;

Keith Deviney (returning member) John Doherty (new member)

Members were given written ballots and asked to vote for or against each of the four nominees. Mr. Fugere and Mr. Iler tallied the votes and revealed the results.

All four nominees were elected as 2018-2019 Board members.

# 7. Other Business:

Concern was raised about the timing of the AGM in relation to the conference in Montreal and that MEAO did not attend.

- The MEAO AGM was booked in the fall to guarantee the date and time well before the Montreal Research Conference on ME/CFS had published their dates.
- MEAO was unable to send a representative due to limited funds and capacity of board members to attend both events so close together.

MEAO is looking forward to the final report from the task force and the implementation of the recommendations. This will be a focus of MEAO's work in 2018-19.

Members thanked Denise Magi for all her hard work and long hours on the MEAO Board and the Task Force on Environmental Health.
