# Update on Government Relations & Advocacy



### 1. Action Plan on Task Force Report on **Environmental Health**

- Despite regular and ongoing advocacy to Minister's office and the Ministry of Health there has been no response.
- •May 10<sup>th</sup>, 2023 in honour of May Awareness Day, CareNow Ontario held a press conference with the support of France Gelinas, NDP Health Critic. All MPPs received a copy of the press release.





### Calls to Action to Government of Ontario

- To implement and fund the recommendations in the Business case for a Centre of Excellence in Toronto, regional MCS safe clinics and local, specifically trained primary care, submitted in 2013.
- 2.To immediately release **Laying the Groundwork**, an action plan developed by Dr. Brian Schwartz, former Vice President, Public Health Ontario, and submitted to the Minister of Health in July 2021.
- 3.To immediately fund the development of case definitions and clinical guidelines for best practices and clinical pathways; fund development of clinical curriculum and require Ontario universities to incorporate this curriculum along with research projects into medical schools and public health schools.



### Action Plan Release: Freedom of Information Request

- The NDP submitted a FOI request in 2022.
- CareNow Ontario received a redacted report that only left the table of contents and the name of the people consulted.
- The NDP has gone through two levels of appeal and in September filed an appeal to the current position that the report will not be released.



### **Action Plan on Task Force Report on Environmental Health**

### **Possible Next Steps**:

- •Question in the house by the Green Party and the NDP
- •Once the Liberal leader is selected, meet with the Health Critic and continue advocacy
- •Begin to look forward to the next election (June 2026) to get this issue on each political party's election platforms.





### 2. CEP Primary Care Tool

Each year CEP is funded by the Ministry of Health to develop tools for primary care physicians. This work is funded through the Primary Care branch.

CareNow Ontario is not clear on who in the Ministry of Health advocated that the CEP Tool for ME, FM, POTs and MCS be on the list for development in 2023-24.

Not clear if this tool is as a result of the 'unreleased' implementation plan. Currently no evidence of other work being done

CareNow Ontario has been clear with Ministry of Health and CEP, that while we cautiously support the development of this tool, it is by NO MEANS sufficient to meet the vision of the Business case for the Centre of Excellence..



### **3.1 Attack on MCS: The Québec**

- In 2022, a study was released by the Institut national de santé publicque du Québec (INSPQ) entitled « Syndrome de sensibilité chimique multiple, une approche intégrative pour identifier les mécanismes physiopathologiques ». This report took the position that MCS was an anxiety disorder.
- Varda Burstyn, lead author and Maureen MacQuarrie, collaborator wrote a comprehensive response outlining the dangers of this approach and presented the biophysical toxicological school of thought entitled « Putting the Chemicals back in MCS »
- The Ontario Advocates for Environnemental Health and CareNow Ontario distributed the responding report to Health Canada, Ontario Ministry of Heath, and Ontario Health.

### **3.2 Attack on MCS: The Binkley article**

- In September 2023, Dr Farah Tabassum alerted us to an article written by Dr Binkley that was released on line in the journal of Allergy Clinical Immunology Practice
- •The hard copy of the article will be published in November 2023.
- The article takes a psychological approach to the causation of MCS.
- •Dr Binkley is an associate professor, dept of medicine, Division of Clinical Immunology and Allergy; and staff at St Michaels and Sunnybrook

### 4. GP Focussed Practice Designation Billing Issue

- In fall 2022, the EHC physicians, under the leadership of Dr Farah ulletTabussum, requested that CareNow Ontario support the EHC in their request to be designated as a GP with a Focussed Practice Designation.
- In December 2022, the Ministry was implementing a new billing process that would allow only family physicians with this Focussed Practice Designation to continue to bill for virtual visits and for longer appointments. This was vital for accessibility for patients across the province with FM, ME and MCS and to ensure EHC physicians had a means to bill for their services.
- The OMA supported the EHC physicians receiving this designation, along with Family physicians who work with trans patients.




### **GP** Focussed Practice Designation Billing Issue

- Dr Farah Tabassum presented this issue on CareNow Ontario May  $\bullet$ meeting.
- In spring 2023, the individual physicians at the EHC received their designation. Dr Kerr still does not have the designation as she did not reach the minimum hours to support her case.

### Next Steps:

- The Ministry of Health and the OMA have begun another round of negotiations.
- Work with EHC physicians to address other related billing issues.
